4. Key responsibility areas

The role is dedicated to working with vulnerable families with disability to reduce demand on the broader family services sector created by the transition to the NDIS.

Service delivery

- Work with vulnerable families to assist with their NDIS access, identifying disability support needs, undertaking disability-related goal setting and helping families prepare for their plan reviews.
- Establish cooperative relationships with local NDIS staff and providers and work alongside IFS Case Managers.
- Work actively and collaboratively with the family and NDIA, Local Area Coordinators and/or Support Coordinators to identify and address the disability support needs of the family.
- Develop a comprehensive understanding of the NDIS funded supports that can contribute to building family capacity and the sustainability of care
- Build the ongoing capacity of other family services practitioners to utilize avenues for secondary consultation and referral.
- Build the ongoing capacity of other family services practitioners to support families to navigate the NDIS and receive timely access to disability supports.
- Build relationships with specialist schools to encourage the early identification and early support of families where the complexity of the disability support needs is likely to cause increased family pressure.
- Work collaboratively with DFFH Divisional Disability and Principal Disability Practice Advisors
 (DPA/PDPAs) to identify families with complex disability support needs at risk of breakdown due
 to unmet disability support needs and who may require a DPA/PDA response. Guidelines for
 Principal Disability Practice advisors are available.

- Demonstrated ability to maintain the balance between face to face client work and administrative tasks such as uploading case notes in a timely manner and arranging key stakeholder meetings.
