Application Technology

- Develop and maintain the application technologies delivery environment to meet the needs of a digital organization.
- Ensure Uniting applications can utilize the standard operating environment (workstations (thin clients) and laptops) by assisting with Application selection.
- Develop strategies that enable single sign-on for Applications by utilizing the Uniting Active Directory
- Ensure that there is an effective licensing management strategy where Application access is limited to authorized users.
- Specify the required transmission, processing and storage capacities required to meet the Application needs.
- Specify and classify all enterprise data storage requirements and the associated risk of loss to the organization and design appropriate risk mitigation and disaster recovery strategies
- Assist in the development of the technical environment to support specialist technologies such as Microsoft Active Directory, Citrix and Application Virtualisation Manager, SQL Databases and network Printing.
- Ensure that the security of data and systems is maintained at the highest of levels.
- Assist in driving the development and implementation of enterprise wide technology improvement opportunities which significantly reduce unit cost or enhance client service experience.
- Ensure appropriate business continuity strategies are implemented for Uniting.
