4. Key responsibility areas

Service delivery

- Develop and maintain the application technologies delivery environment sufficient to meet the needs of a digital organisation.
- Develop and maintain a diverse portfolio of applications across the organization
- Assist in driving the development and implementation of enterprise wide technology improvement opportunities which significantly reduce cost or enhance client service experience
- Support application management strategies to consolidate, reduce risk and associated costs.
- Ensure proposed applications are aligned to ICT and business strategic requirements
- Market scanning for new applications and solutions to support business growth and service delivery targets
- Manage all stages of application lifecycle management from implementation through to decommissioning.
- Collaborating with SMEs, Project Leads and broader ICT team to resolve issues and ensuring solutions are viable and consistent
- Actively support the establishment of a Business Systems Administration community of practice
- Liaise with internal and external PMO, Governance and Consultancy bodies – under the guidance of the Application Technology Manager
- Oversee the implementation of systems, working closely with the business, Quality and other business and technical team members
- Conduct Business Analysis using industry standard process mapping techniques and tools UML/BPMN and Archimate (desirable)
- Assess and prepare detailed implantation plans for migration of Microsoft SQL server and Access databases to more modern frameworks (such as MDW or Platform as a service database)
- Support technology and business application projects working closely with project teams

- Tertiary qualification in an Information Technology field or related industry experience

- Proven experience with technical requirements gathering and the ability to derive practical business outcomes, using technology in a large organisation.
- Proven experience implementing business systems & applications within large organisations.
- Strong technical/functional design, planning, risk and change management skills.
- Modern applications architecture, better practice Microsoft cloud technology and use of Modern data warehouse and Power BI
- Capability in applications architecture development (e.g. TOGAF) and Business Analysis tools such as UML and BPMN and well as TOGAF
- Working knowledge of databases (SQL Server/Access) and programming languages (VBA for Macros)
- Experience supporting RFP/RFQ processes
- An understanding of a customer first approach and linkage of organisational roles/systems applications to the customer
- Must be able to work independently where appropriate and also contribute to the shared values and activity of the wider team.
