- work with communities, individuals and agencies to develop and establish an evidence base for innovative solutions
- building on the strengths, skills and organisational capacities of communities

Program delivery	<ul> <li>Ensure operational delivery of Communities for Children in East Gippsland to meet the deliverables of the program</li> <li>Ensure reports, financial adquittals and evaluations are completed in a timely manner and in line with funding requirements</li> <li>Ensure data entry into DEX is completed in a timely manner</li> <li>Maintain communication with the allocated funder representative</li> <li>Maintain relationships, provide support and information and monitor contracts with external Community Partners</li> <li>Facilitate the Communities for Children Advisory Group</li> <li>Ensure all program activities are operated in line with relevant legislative and sector standards</li> <li>Actively engage in and/or facilitate relevant partnerships, networks and meetings to advocate for vulnerable children and families, facilitate links and engagement between services and families and represent Uniting in a positive manner</li> </ul>
