# Service delivery

- Support early childhood teachers to complement their knowledge and skills, while acknowledging their expertise in supporting children's learning and development
- Support early childhood teachers to build their capacity to develop and implement an inclusive program
- Assist early childhood teachers to contribute to positive outcomes for all children, as defined in the Victorian Early Years Learning and Development Framework (VEYLDF)
- Assist early childhood teachers to enhance children's learning and development by responding to each child's interests, abilities, and needs
- Promote collaboration between the family, other professionals and early childhood teachers
- Recognise that early childhood teachers require varying levels of additional support
- Assist early childhood teacher to implement a team approach to support inclusion of all children
- Support early childhood teachers to Implement previously identified adaptations to the program, activities, routines and environment
- Assist early childhood teachers to respond to newly identified learning and development needs of all children
- Support all children to access and meaningfully participate in all aspects of the program
- Assist early childhood teachers to respectfully engage with families and respond to families concerns
- Provide early childhood teachers with network links and collaborate with other professionals
- provision of resources and information linkages to professional development opportunities (for example training, professional networks)
- One-to-one consultation and coaching sessions (onsite, telephone)

- Ability to liaise with Early Childhood professionals, and the community regarding the access and participation of children with additional needs in funded kindergarten services
- High level skills in building and sustaining professional partnerships with early childhood teachers
- Ability to implement capacity building strategies through coaching and mentoring
- Well-developed ability to build and manage diverse networks and form collaborative partnerships with early childhood professionals
