#### **Network Services**

- Coordinate the development and maintenance of a Wide Area Network (WAN) that integrates all sites within Uniting VicTas sufficient to meet the business, access, and security needs of a digital organization.
- Coordinate the development and maintenance of an effective Local Area Network that integrates all staff within Uniting VicTas into the WAN, sufficient to meet the business, access and security needs of a digital organization.
- Establish an effective maintenance and support strategy for WAN and LAN to ensure that the expected resiliency, productivity, and security requirements are met.
- Establish standards and policies to guide the planning and implementation of local area networks and related cabling, communication hubs/racks/rooms whilst recognizing that a mixture of fibre, copper and wireless strategies may be required.
- Review power requirements and ensure power resiliency when indicated by business requirements.
- Ensure that the security of the network is maintained at the highest of levels.
- Assist in driving the development and implementation of enterprise-wide technology improvement opportunities which significantly reduce unit cost or enhance client service experience.
- Ensure appropriate business continuity strategies are implemented for Uniting.
