### 2. Position purpose

The Occupational Therapist is responsible for quality community-based services to individuals and groups within our community. This role includes home, outreach and centre based assessment, focusing on living skills training and management of clients with a wide range of complex issues, such as medical conditions, disabilities, mental health and alcohol and drug taking behaviours. Liaison with the greater Street 2 Home team and external organisations for a comprehensive and effective follow up for consumers is a key part of this role.

The Occupational Therapist will work within a Specialised Housing Support and Assertive Outreach Team to provide a holistic, client centred approach and coordinated response plans. Using a strengths-based approach, the OT will collaborate with clients, workers and other service providers to develop meaningful care plans. This includes a focus on educating and empowering clients to adopt self-management strategies to improve their health which is underpinned by health literacy principles.

### 5. Key responsibility areas

### Service delivery

- Undertake client assessments, provision of information, brief interventions, and care work for clients with complex needs.
- Development of comprehensive treatment plans following clinical assessment of client needs
- Development of independent living skills and community engagement to improve quality of life
- Provide a high quality and flexible Occupational Therapy service to clients who are in the housing model in accordance with program expectations.
- Offer intensive case management to clients in a home based setting.
- Assist in the creation and maintenance of a stable living environment for those with complex needs.
- Develop individual treatment plans with each client to address issues that can be created
  and exacerbated through the combination of substance use, physical and mental health
  disorders, and homelessness.
- Improve the quality of life for people with complex, concurrent conditions.
- Assist clients in the housing program transition to permanent housing in accordance with DHHS requirements, and provide appropriate support following transition
- Provide timely services across a range of funding sources mainly through NDIS and HACC
- Liaise with a range of stakeholders to ensure comprehensive and effective client management including purchase of equipment.
- Provide a welcoming approach where clients are able to learn about a range of matters and engage in self-management.
- Participate in multi-disciplinary coordinated activities to meet the needs of the target group.

- Refer, consult and liaise with staff within the team and greater organisation and other local agencies to ensure a holistic multi-disciplinary approach to client needs.
- Incorporate health education into direct care contact using health literacy principles.
- Maintain the required caseload and meet associated agency and funding body administrative and reporting requirements (record keeping, statistical data entry, timely reporting).
- Take responsibility for program delivery quality and target achievement in accordance with established program policies and procedures, agency expectations, and funding quidelines.
- Take responsibility for addressing professional development needs (induction, training, supervision and support).
- Develop networks and referral pathways with other service providers.
- Other duties as required.
- Contribute to the achievement of quality improvement, both in terms of individual and program performance by encouraging an environment where high quality work is achieved and supported by the adherence to/development of quality systems documentation

### Contribute to a legislative compliance culture throughout the program by ensuring familiarity and adherence to relevant laws, regulations, industry codes and policies/procedures that may impact on day-to-day activities. Reporting breaches and incidents to the Responsible Officer and/or other Officers as necessary.

- Participate in and contribute to quality student participation and related tasks to support Occupational Therapy student placement and professional skill development.
- Perform other duties consistent with the aims and objectives of Uniting as directed by the program coordinator.
- Contribute to the monitoring, evaluation and reporting on the overall performance of the program.
- Contribute to the development of appropriate operational manuals, policies and procedures of the Street 2 Home Program.

### Promote collaborative teamwork within the Overdose Response team and across partner agencies.

- Actively participate in ongoing professional development via the annual performance reviews, individual and group supervision provided by Uniting and attend relevant training as required.
- Support the student placement program and supervise students as requested.
  Ensure adequate program records are maintained according to legislative and DHHS funding requirements.
- Ensure the maintenance of up to date progress notes, case files and data entry across teams and they are kept in a confidential manner.
- Ensure accurate and up to date records are kept regarding operational activity i.e.: timesheets, meeting minutes, supervision records etc.
- Assist in the preparation and writing of relevant reports.
- Contribute to the achievement of quality improvement, both in terms of individual and program performance by encouraging an environment where high quality work is achieved and supported by the adherence to/development of quality systems documentation
- Adhere to and keep informed of all relevant legislative compliance requirements, and report any perceived breaches, risks, hazards, incidents and complaints to line Manager or other appropriate person.
- Undertake other duties as required by the Street 2 Home Coordinator.
