#### 1. Position purpose

Our Op Shop Managers manage the day-to-day operational requirements, development of people, and performance of one of our Op Shops.

The Op Shop Manager will work in the Op Shop supporting their team (employee and volunteer) to offer positive customer experiences, high level visual merchandising, critical stock and space management, achieve sales targets, and embed Uniting's culture, policy and procedure within their practice.

#### 2. Scope

## **Budget:**

In line with the Delegations of Authority, Op Shop Managers are responsible to archiving sales targets and ensure expenditure is in line with local budgets.

Op Shop Managers will have 1-2 direct reports, and a cohort of volunteers. The positions include:

- Volunteers (reporting to Op Shop Managers)

#### 4. Key Responsibility Areas

#### Service delivery / profitability:

- Organise and sort stock in preparation for sale.
- Support Area Managers to ensure that Op Shops have high profiles within local communities and across social media channels, this is done by providing photos, videos and building local partnerships.
- Bring creative flair in achieving visually dynamic and contemporary Op Shops through use of high-quality visual merchandising.
- Champion ethical practice, waste reduction and circular economy principles.
- Build unique and positive customer experiences.
- Be aware of the diverse needs and backgrounds of consumers and volunteers building spaces of acceptance and respect.
- Treat consumers and customers as equally as possible, maintaining a duty-of-care and trauma-informed practice.
- Share sales data with your team to motivate engagement and performance.
- Support the growth and operations of Op Shops by engaging in events, pop ups, and crossorganisational gatherings.
- Work with your team to assist them in developing, understanding, and achieving budgets and targets.

#### Quality and risk:

- Support opportunities to integrate and work collaboratively across Uniting.
- Undertake administrative tasks including compliance with Uniting's policies, procedures, and reporting.
- Encourage volunteer, donor, customer, and consumer feedback and ensuring it is appropriately recorded, reported, and followed up in a timely manner.
- Maintain and improve stock identification and merchandising including best practice stock and space management.

## **Op Shop Manager**

- Monitor pricing of goods in Op Shops, and report on sales trends.
- Be aware of designer, vintage, collectable, and valuable goods to optimise value where appropriate direct goods to a premium op shop location.
- Report weekly on trends, challenges, celebrations and matters of operational significance.
- Manage finance and banking procedures, ensure regular banking and accurate data entry.

#### People and teams:

- Build relationships based on trust and honesty with employees, volunteers, customers, consumers, and donors.
- Provide support, guidance, coaching, and leadership, to inspire and empower the team including critical feedback through performance reviews and regular supervision.
- Engage and support a culture of productivity, imagination, innovation, change and development.
- Encourage your team to tap into their natural way of being creative, enthusiastic, and having
- Find simple ways to delight people in a meaningful, memorable way.
- Manage and resolve conflicts as soon as possible, seeking guidance as required.
- Ensure employees and volunteers are correctly orientated to Uniting and Op Shops.

#### **Legal requirements and risk management:**

- Ensure all legal, funder and statutory requirements pertaining to the position are met including serious incidents, reportable conduct, and mandatory reporting (child safety).
- Foster a culture where risks are identified and appropriately managed.
- Report areas of serious risk to next level supervisor and work together to mitigate those risks.

- Cooperate with strategies to actively ensure the safety, protection and well-being of children who come into association with us.

- Work collaboratively with Uniting (Victoria Tasmania) employees and external stakeholders in accordance with Uniting's values and professional standards of behaviour.
- Actively participate in initiatives to maintain, build upon and promote a diverse, positive, and collaborative workplace.
- Identify opportunities to integrate and work collaboratively across teams.
- Take reasonable care for your own health and safety, and health and safety of others (to the extent required).
- Promote a positive safety culture by contributing to health and safety consultation and communication.
- Promptly respond to and report health and safety hazards, incidents, and near misses to line management.
- Attend mandatory training sessions (i.e. equal employment opportunity, health, and safety) and mandatory training specific to position.
