Key responsibility areas

Service delivery

- To support and educate carers to increase their understanding of the child/young persons'
 experience of trauma, with the aim being to increase the child/young person's social,
 emotional, behavioural and developmental functioning.
- To provide carers individualised education regarding the child and their presentation/behaviour.
- To observe the child/young person and their interactions with their carer/s in their home environment.
- Contribute to case plan and professional meetings as negotiated.
- Liaise with relevant professionals, and provide education and support to the child's network if required.

Duties and responsibilities

- Provision of specialist consultation to case managers, carers, client families and other professionals
- Facilitation and participation in a reflective learning environment within the program and organisation
- Develop and maintain skills and ethical practice to a high level according to best contemporary practice
- Manage the development and delivery of specific portfolio projects
- Manage the development and co-ordination of groups for families, children & young people
- Maintain privacy and confidentiality as per organisational policy
- Maintain data systems including timely collection, uploading and reporting
- Active mentoring to students / interns and other staff
- Maintain professional conduct and ethical practice in accordance with the Code of Ethics of relevant professional society and Uniting policies
- Other projects and duties, as required

Administration

- Contribute to developing program-related literature and documentation
- Collect and analyse data to support strategic direction of the program
- Write high quality, accurate, timely and thorough documentation of client work
- Additional reporting as required for stakeholders such as for Department of Health and Human Services

 - Shows awareness and understanding of child abuse and neglect
 - Demonstrates a knowledge of practices to engage and assure the cultural safety of clients from a diverse range of backgrounds, including those from an Aboriginal, Torres Strait Islander or Culturally and Linguistically Diverse (CALD) background, or the LGBTI community.
