Position purpose

In light of the Covid-19 response, the Immediate Assistance Practitioner's role will sit under the Family Violence Services Program and provide phone-based and outreach support (when appropriate) to women and children affected by family violence to address their immediate safety and stability. The practitioner will be required to complete initial risk assessments and safety plans and provide support including, but not limited to funding applications; purchase of goods and services; sourcing of temporary accommodation; advocacy; and referrals to other services.
