Project requirements

Under the direction of the Group Manager Eastern Melbourne, the project officer – Project and Recruitment will provide advice, leadership and coordination on complex and operational matters :

- Provide specialised support to Managers of Home Based Care (HBC) programs, across business units, to collectively improve Uniting's capacity to respond to external inquiries from prospective volunteer carers.
- Undertake a detailed analysis of current Uniting practices and processes, in relation to foster carer inquiries and provide recommendations to Uniting on areas for improvement and development in this area.
- Recommend improvements on Uniting's Website, in relation to the foster carer interface, and work collaboratively with the Marketing/ ICT teams to implement these improvements.
- In collaboration with key stakeholders, assist to deliver the implementation of a 1800 number, used to respond to carer inquiries.
- Undertake a cost analysis (remuneration) of current carers responding to (foster care) inquiries, compared with Uniting staff responding to these inquiries. Provide recommendations to management on findings and impact on resourcing budget.
- In collaboration with HBC management and People and Culture team, develop and implement a Uniting online training platform for volunteer carers
- Develop project meeting agendas and ensure project meeting outcomes are delivered.
- Participate in ensuring a consistent Uniting wide Foster Care recruitment strategy is developed and implemented.
- In collaboration with HBC managers, project group; and lead by the Group Manager, ensure the Foster Care recruitment strategy outcomes are achieved.
- Provide the Group Manager and HBC Project Team with reports, expert advice and information relevant to the work area
- Provide recommendations to management on the project's planning, reviewing and implementation life cycle.
