2. Position purpose

The position of Registered Nurse is based in a specialist care unit in a residential setting which provides comprehensive professional health care to individuals with Huntington's disease, other complex neurological disorders and spinal cord injury.

Uniting Neurological Support Services (UNSS) offers specialised residential accommodation to people who have progressive neurological conditions. Residents at UNSS have complex health care needs that may impact them physically, psychologically and cognitively. Neurodegenerative diseases often involve significant complex behavioural and psychological symptoms. A major focus is on people with Huntington's disease.

UNSS operates across two sites, a 30 bed facility, comprising three separate houses, each with 10 residents, in Burwood East and a 6 bed facility in Glen Waverley.

5. Key responsibility areas

Service delivery

- Sensitively establish, maintain and adapt effective therapeutic partnerships with individuals with life-limiting illnesses, their caregivers and family according to individual needs, circumstances and preferences.
- Demonstrate respect for uniqueness and individual autonomy when responding to the individual's experiences and response to dying and bereavement.
- Provide assistance to individuals with Huntington's disease and other complex neurological disorders with daily living activities in a community based residential setting.
- Ensure as part of a team that individual support needs of residents are being addressed by the service.
- Ensure that at all times residents are treated with respect in a manner that enhances their personal dignity and rights.
- Actively promote a home like environment that enhances the residents' wellbeing and is welcoming to families, friends and others.
- Provide palliative care, clinical assessment and the management and administration of all scheduled and other medications required for this.
- Provide direct and comprehensive professional health care to 30 individuals with Huntington's disease, other complex neurological disorders and spinal cord injury in a community based residential setting.
- Ensure individual care needs of residents are being addressed by the service.
- Attend to medical treatments (such as wound care, catheter care and peg feeds) to residents as required.
- Carry out Administration and Management of resident medications according to the legal and ethical standards of the Disability Services Act, DHHS and DoHA Guidelines, Victorian

Drugs, Poisons & Controlled Substances Act/Regulations 1981, Victorian Disability Services Practice Manual Medication Guidelines and WNSS Policy and Procedures.

- Ensure that Infection Control Standards are maintained.
- Ensure palliative care requirements of residents are attended to.
- Is responsible for immediate decision-making and appropriate action in the event of a *medical emergency*, e.g. choking, aspiration or injuries, and provides ongoing monitoring, supervision and reporting as appropriate to the situation.
- Participate in the review and implementation of Holistic Individual Care Plans for each resident.
- Participate in the review and implementation of resident behaviour management plans.
- Verify death and carry out documented procedures required for this. Notifies the House Clinical Coordinator and Clinical Operations Manager.
- Carry out other duties as directed by House Clinical Coordinator.

Communication

- Give and receive hand over to other nursing staff.
- Communicate with families as to the medical/health needs of the residents after hours and as directed by House Coordinator.
- Liaise with doctors and health professional staff regarding ongoing resident support with reference to changes in condition, behaviour, and/or swallowing difficulties, ensuring that information is disseminated to appropriate staff as directed by the House Co-ordinator.
- In consultation with medical practitioners, order resident medication as required.
- In consultation with the House Clinical Co-ordinator make referrals to allied health and specialist services when required.

Documentation

- Ensure appropriate health documentation and records relating to residents is maintained to a high standard and that medical and nursing care components in the Resident's Individual Care Plans are kept up to date.
- Maintain accurate security and accountability and overall management of the administration of resident medication according to the legal and ethical standards of the Disability Services Act, DHHS and DoHA Guidelines, Victorian Drugs, Poisons & Controlled Substances Act/Regulations 1981, Victorian Disability Services Practice Manual Medication Guidelines and NS Policy and Procedures.

Personal Accountability

- Compliance with Uniting's values, code of conduct, policies and procedures and relevant government legislation and standards where relevant
- Ensure appropriate use of resources.
- Work collaboratively with Uniting (Victoria Tasmania) employees, founding agency employees and external stakeholders in accordance with Uniting's values and professional standards of behavior
- Actively participate in initiatives to maintain, build upon and promote a positive and collaborative workplace
- Identify opportunities to integrate and work collaboratively across teams.
