The position also leads reflective practice sessions with staff to problem-solve and collaboratively develop and review strategies and approaches that promote children and young people's healing and progress towards desired outcomes.

Develop and sustain service partnerships and linkages to promote joint therapeutic work, particularly with relevant Aboriginal services Conduct thorough assessments and develop a therapeutic treatment plan for each child or young person that is regularly reviewed and updated and applies across all spheres of the child or young person's development including physical, emotional, social, educational/vocational, recreational, cultural and spiritual Participate as an active member of the care team in all relevant care team meetings, operational groups and panels and maintain regular planned telephone consultation with care team members as agreed regarding the needs of the child, care family and other key stakeholders. Provide regular planned and unplanned specialist therapeutic support and advice to the care team in accordance with the therapeutic care plan.
