Gippsland Youth Residential Youth Rehabilitation Program provides a 24 hours per day, 7 days per week residential services to young people aged 16-25 with a combination of Department of Health funding and client contributions.

- Provide support to the clients who have an experience of issues relating to their alcohol and other drug use or mental health.
- Support clients to achieve their recovery goals through peer and individual program activities and group work facilitation.

This role will contribute to the effective operations of the Gippsland Youth Residential Youth Rehabilitation Program through the provision of a quality food offer for clients through the ordering, stock control and effective and efficient kitchen operations. The position will also provide individual and group support in the context of individual meal plans, healthy eating planning and support for clients in the development of their cooking and meal planning skills

Provision of food preparation and service

- Working with suppliers to improve product/s;

- Understanding the health and dietary requirements of each client;
- Liaising with dieticians regarding special needs;
- Following a continuous improvement process, including critiquing quality and presentation on a daily basis;
- Minimising wastage on a daily basis;
- In consultation with the Manager, ensuring that appropriate and effective arrangements/options are in place for weekend food service;
- Provide the opportunity for clients to work within the kitchen to further develop their skills;
- Other duties as directed

Collaboration and Partnerships

- Work effectively and authentically as part of a team in assisting clients to achieve their cooking and meal planning skills;
- Contribute to an inclusive workplace environment and culture which supports diversity, develops teamwork and ensures the provision of quality services for clients;
- Develop and maintain effective relationships within the team and with external stakeholders to ensure clients receive the highest quality, co-ordinated food service;

People and teams

- Undertake regular supervision and performance review with line manager, proving feedback to promote collaborative working relationships
- Promote and maintain a positive, respectful and enthusiastic work environment
- Provide authentic team leadership and the highest level of professional conduct in alignment with Uniting's values.

Food Safety/Kitchen Operations and Maintenance

- Responsible for ensuring the cleanliness of the kitchen and dining area;
