#### The competencies required in the first 12 months are;

- CHCAODoo1: Work in an alcohol and other drug context
- CHCAODoo2: Work with clients who are intoxicated
- CHCAODoo4: Assess the needs of clients with alcohol and/or other drug issues
- CHCAODoo9: Develop and review individual alcohol and other drug treatment plans

#### The competencies required in the first 24 months are;

- CCHAODoo6: Provide interventions for people with alcohol and other drug issues.
- CHCAODoo7: Develop strategies for alcohol and other drug relapse prevention and management
