1. Position purpose

This position works closely with the Infrastructure Manager to ensure that there is appropriate and relevant technology strategies, planning, implementation and operations to meet the system administration needs of the access, processing and storage infrastructure within Uniting.

This position ensures that there is recognition of the role of innovation, leading practice and quality, in concert with functionality and resilience, to deliver effective systems that support Uniting employees. The role is expected to ensure that the system solutions implemented by Uniting effectively underpin the Uniting service delivery by facilitating staff productivity and assist clients engage with the required service.

By providing in-depth technical skills and experience to the capability of the team this position will be a point of escalation for the team to work together to resolve complex issues and/or associated underlying problems with primary responsibility to configure the Cloud Management service and to monitor /manage the services.

4. Key responsibility areas

Systems administration

- Lead and coordinate the development, support, and maintenance of the Data Centre(s) processing and storage facilities within Uniting Vic Tas, sufficient to meet the business, access and security needs of a digital organization.
- Lead, coordinate, develop and maintain an effective user access, authentication and authorization strategy for the data processing and data storage facilities to ensure that the expected resiliency, productivity, and security requirements are met.
- Deliver enterprise-wide printing services
- Establish monitoring and reporting services to inform the business continuity, planning and improvement process.
- Review power requirements and ensure the level of power resiliency that is indicated by business requirements.
- Ensure that the security of the processing and storage facility(s) is maintained at the highest of levels.
- Assist in driving the development and implementation of enterprise-wide technology improvement opportunities which significantly reduce unit cost or enhance client service experience.
- Ensure appropriate business continuity strategies are implemented for Uniting.

5. Performance indicators

- Uptime and Availability: Measure the percentage of time the cloud services and infrastructure are operational and accessible.
- Incident Response Time: Track the time taken to respond to and resolve incidents.
- Resource Utilization: Monitor the usage of cloud resources (CPU, memory, storage, etc.).
- Cost Management: Evaluate the ability to manage and reduce cloud spending. This includes tracking cost savings through optimization strategies and adherence to budget.
- Deployment Frequency: Measure how often new features, updates, or patches are deployed.
- Backup and Recovery: Track the success rate and speed of backup operations and recovery processes. Ensuring data is consistently backed up and can be quickly restored is critical.
- Security Compliance: Monitor adherence to security policies and compliance with relevant standards (e.g., ISO 27001, RFFR).
- User Satisfaction: Gauge the satisfaction of internal and external users through surveys and feedback.
- Change Success Rate: Measure the percentage of changes (updates, upgrades, patches) that are successfully implemented without causing disruptions
- Automation Coverage: Track the extent to which cloud operations and processes are automated.

- Proven experience in the area of Data Centre Management, Server and/or storage administration design and/or management using leading technologies and maintaining operational excellence within a medium to large service organisation.
- Demonstrated experience in defining, procuring and delivering effective services to support the processing and storage requirements of a large multi-site enterprise.
- Proven experience within standard Data Centre environments with a strong emphasis on Data and processing virtualisation.
- Proven understanding of the management and control of cloud environments including: IaaS, PaaS and SaaS, particularly within Azure and/or AWS.

- Proven experience in establishing effective vendor support through monitoring, maintenance and reporting.
- Proven experience in risk identification and mitigation, including the maintenance of network services during primary power loss or other link events
