About the 2021 Share Grants Program

Since 1980, the Share grants program has existed to provide financial assistance that will enhance the quality and scope of UnitingCare and Uniting Church services to the community in Victoria and Tasmania.

With Share now part of Uniting, this year's Share Grants are for parish missions, congregations and others who would have historically applied.

To finance its grants, Share had run a number of direct mail and congregation based appeals and campaigns. Uniting continues to run Share appeals (at Winter and Christmas) and the amount distributed continues to be completely dependent on the generosity of donors to these appeals.

The funding priorities remain to be for projects that meet at least one of the following purposes:

- Directly address urgent human need
- Are preventative in nature
- Tackle underlying structural causes of disadvantage
- Improve the quality of community services.

There will be two core grant categories:

1. General and Emergency Relief Grants

These grants are for general projects up to \$50,000 conforming to the purposes as listed above. Projects may include:

- Care and support of disadvantaged groups or groups with significant support needs e.g. asylum seekers
- Education (including life skills)
- Counselling and advocacy
- Family strengthening and early intervention programs
- Social outreach initiatives e.g. drop-in centres, men's sheds
- Coordination of volunteers who deliver programs
- Emergency relief services e.g. material and food aid.

2. A & H John's Bequest

Grants of up to \$50,000 are also available from the A & H Johns Bequest Fund which exists to provide financial assistance for programs that enhance the quality of life of physically disabled younger people. Only Victorian based Uniting Church organisations may apply.

Low priority is given to applications that include:

- Capital expenditure such as purchase of vehicles and equipment
- Purchase of property or land
- Renovations
- Research (except where it is part of an actual service program)
- Staff wages.

How to Apply

Requirements

Uniting Church Organisations:

Applicants must be agencies of the Uniting Church or organisations with strong links to the Uniting Church i.e. ecumenical programs in which the UCA is a significant partner.

Mandatory Tax Deductibility:

Please note that grants are only available to those organisations with deductible gift recipient status.

No Auspicing:

Grants will not be made to auspicing agencies for the benefit of third party agencies who do not have tax deductibility.

Previous acquittals required:

Grant funds will not be paid to organisations that are in breach of reporting requirements from previous Share grants.

Note: there is no pro forma or formal template for acquittals. Please provide copies of any reports, financial statements and invoices pertaining to the project which show how the funds were used and any supporting documents which provide commentary around whether the objectives set out in your application were achieved (e.g. annual report).

Successful and unsuccessful applicants notified *	Early September 2021
Successful applicants receive official letter of offer and funding agreement	Mid-September 2021
Grants paid	One week following signed agreement has been received with bank account details.

**Successful applicants are notified of provisional funding amounts. The final amount may vary depending on the funds available.*

Helpful hints

- Ensure you do a spelling, grammar & punctuation check and the application is proof read by someone who didn't help write it
- Ensure that the objectives of the general grant applications are clearly aligned with the stated outcomes. A mismatch indicates to us a lack of clarity in the application or the project itself
- Clearly articulate how the outcomes of the project will be measured.
- If you are developing a new service, explain in the rationale section how and why it is necessary
- Provide a clear budget outlining all line items
- Outline how the project will be funded outside of the Share grant.

How we will assess applications

Historically Share received more grant applications for worthy projects than were able to be funded. There will continue to be a comprehensive assessment process consisting of a selection panel to identify the projects that represent the greatest need and will achieve the most impact in addressing the funding criteria. To be successful your application must address a well-defined need, and have an ongoing, positive impact in the target community. It is also important that the project is sustainable in the long-term without relying on receiving an ongoing Share grant.

If you apply for part funding of a project, please be clear on the component of the project that the Share grant will be funding (and where you will be sourcing your additional funding from) to ensure we can assess your application properly.

If you are successful

We will email successful applicants in early September with provisional funding advice. In mid-September we will send you a confirmation email with the final amount and post you an official letter of offer and funding agreement. We will transfer the funds by electronic funds transfer once we have received the signed funding agreement.

If you are not successful

We will notify you by email in early-September. We will do our best to provide feedback but this may not always be possible.
