



Relief Due to Hardship Policy

1. Policy

Uniting Vic.Tas (Uniting) will help renters to manage their tenancy by providing them with information, support, and access to services, so they can maintain their tenancy wherever possible when a change in a tenant's household circumstances affects their ability to pay rent.

2. Scope

This information applies to all rental properties owned and managed by Uniting Housing

3. Procedure

Uniting representatives will:

- ensure that renters are given every opportunity to sustain their tenancy during times of financial hardship.
- allow a renter to apply for a temporary rent reduction under this policy.
- require the renter to provide evidence to support the application, which may include but is not limited to:
 - Separation Certificate from employer
 - o Centrelink statement confirming new/reduced income.
 - Dates of entry to facility and expected exit date.
 - Personal financial liability for fees for lodging and services
 - o Evidence that a partner or income earning child, has vacated the property.

The Senior Manager may:

• approve reduced rental payments for an agreed period of time on a case by case basis, until a review date.
