



# **Pets Policy**

# **1. Policy**

Uniting Vic.Tas (Uniting) acknowledges the value of pets to renter's health and wellbeing, and the responsibilities renters have to those pets and others in the community.

Uniting will manage renter's applications to keep a pet at a Uniting residence in accordance with relevant legislation.

## 2. Scope

This information applies to all rental properties owned and managed by Uniting.

## **3. Procedure**

### Uniting representatives will:

- require renters to:
  - apply to Uniting to keep an animal in a property owned by Uniting on the <u>Pet request form</u>
  - apply for third party permission, for example when a property is in a head leased arrangement with Uniting and provide evidence of the outcome of the application on request.
  - only keep an animal as permitted in legislation, for example Local Laws requirements for registering and keeping pets
- when assessing applications to keep a pet, consider:
  - o any rule, like strata rules, that control pet ownership
  - the type and number of animals. In most situations, Uniting will not permit more than two pets per household.
  - o the suitability and welfare of the animal
  - if the animal is an assistance or service animal in terms of relevant legislation
  - the potential or history of the animal interfering with the reasonable peace, comfort, and privacy of neighbours
  - o professional advice, as appropriate

- manage complaints or damage caused by an animal in accordance with relevant policy and procedure.
- withdraw permission to keep an animal on the basis of following relevant policy and procedure.
