- Ensure when engaging volunteers that they are suitable for the role, can align with the Code of Conduct and are able to promote the values as a representative of Uniting
- Provide the Marketing and Communications team with suitable short stories that promote the positive experience of volunteering within Uniting and connecting with customers within aged and carer programs
- Maintain data systems and provide reports as required
- Engage with the Volunteer Engagement team and the broader aged and carer team to promote and maintain a positive and collaborative team environment, working together to provide the best outcomes for customers and volunteers
